The CSIA's Structure

The Cyber Security Industry Alliance is an independent legal entity, a 501 (c) (6) organization incorporated in the state of Delaware in the United States. The organization is led by a slate of officers, elected by the board of directors. The board governs the direction of the Alliance and is chartered with helping the organization's officers fulfill its mission and with seeing that the Alliance operates in the best interests of its members and according to its bylaws.

A full-time Executive Director and CSIA employee, Paul Kurtz, provides leadership to the organization. Paul is a former White House staffer with extensive experience in cyber security and national security issues.

Though the Alliance's primary legal entity is a 501 (c) (6) non-profit corporation, the portion of annual dues used for lobbying are not tax-deductible.

Membership

The Cyber Security Industry Alliance has a four-tier membership structure: Charter Members (annual dues \$150,000) are committed and involved companies that seek the most influence over the organization and its programs; Principal Members (annual dues \$60,000) seek a strategic level of participation; Affiliate Member - Large Enterprise Partner (annual dues \$30,000) firms that provide operating or networking systems, or system integration; Affiliate Member - Emerging Security Partner (annual dues \$12,000) Cyber security firms with fewer than 100 employees and less than \$10M revenue. **Charter and Principal memberships must be approved by the CSIA Board of Directors.**
